Food Service License is Coming

The Club is in the process of applying for a food service license. At the end of last season, the Board of Health notified the Club that it could no longer serve food without obtaining this type of license. Although our galley, when inspected, was found to be one of the best equipped on the island, it needed two modifications before a permanent license could be obtained. Since that time, the Club has obtained a temporary license each time food has been served.

Over the winter Bob Bahney and Jack Lain have been working with the Board of Health and island contractors to obtain and install a grease trap on our dish washing sink. Raymond Arth has donated a vegetable sink and the necessary cabinets and countertop which he is currently having made in Cleveland. This should be ready for installation the beginning of May. At that time, the Club will move forward with it's application for a food service license. Until that time, temporary licenses will be obtained as needed for caterers and club functions.

Commodore's Briefings

The Spring 2001 I-LYA meeting is history. I-LYA confirmed their intent of returning to Put-in-Bay for the 2001 Regatta and to use the Club facilities. A very successful hospitality room was hosted by our Club on Friday night. FC pati Arth and other volunteer PIBYC members created an island theme with palm trees, boats, lines, pilings, flowers and grass skirts. It was a special place where we all gathered to greet our I-LYA friends.

The PIBYC Board Meeting was held Saturday morning. Preceding this meeting, PC Reni Miller, Project Manager, reported on the progress of the new format planned for this summer.

The preliminary work of obtaining the liquor license is

moving forward in slow motion. We are hoping to have the license by early summer. In the meantime, we will definitely be going ahead with the Friday night food service.

I am happy to report our projected revenue from Club rentals should exceed last years. We are trying to fill the gaps without affecting our scheduled Club events. These include many mid-week private events that will take place when we have no club functions.

I look forward to seeing you at Clean-up Day and at the official opening of the Club on Memorial Day. The Memorial Service will be followed by the Eye Opener Brunch.

Update on Club Liquor License

The Rules and Regulations, for the serving of beer, wine, or alcoholic beverages by the Club or by caterers using the Club, were brought to the Board's attention at the end of last year s Season. After much investigation and discussion it was agreed that the best course for the club to pursue at this time is to obtain a Club liquor license.

This license will completely eliminate the need for members to carry private bars to club functions. It is the Club's intention to offer full (but simple) bar service on a scheduled basis at reasonable prices. Member's favorite brands can be stocked, requests should be made to Sharon Conte, the Food and Beverage Manager.

Most of the necessary paperwork is complete. A current membership roster was requested by the licensing agency and members may be contacted by phone or requested to attend a meeting regarding the issue. Please take time to respond if contacted. Your opinion is important.

The process should be complete sometime in June. More information and a schedule will be included in the June *Jib sheet*.

Club Charge Available

This year, the club will be offering a club charge option. Members will be able to charge food, beverage, and activities at the club. A monthly bill will be issued.
